In consideration of my child(ren) participating as a Student Member of the Canal Winchester “Marching Indians”, I agree, as the parent(s) or legal guardian to the financial responsibility and fees charged by the CWPAB. I agree that these fees charged by the CWPAB are to be used to cover costs incurred as a member of the Canal Winchester Marching Band.

- I agree, all CW Marching Band participation fees are to be paid in full by the required due dates.

- I agree, any unpaid Marching Band fees after the payment due date will result in my child being unable to attend summer band camp during this current band season and will be considered an alternate during the marching band season.
- I agree, if unable to fulfill my obligation to pay the required Marching Band fees, I will contact the CWPAB Treasurer at [treasurer@cwpub.org](mailto:treasurer@cwpub.org) to arrange a meeting to discuss options at least one week prior to any fee payment deadline. If I do not make this contact in advance with the CWPAB Treasurer, this will constitute non-payment of fees and a violation of this agreement.
- I agree all Marching Band fees are non-refundable after published cancellation deadlines.
- I agree, any special Marching Band fees agreed to during the season, in addition to the base fees at the beginning of the season, are my responsibility and shall be paid by the due date listed on the invoice and/or statement.
- I agree, and understand, I am entering into a binding agreement with the CWPAB for fees incurred during the 2011 Canal Winchester Marching Band season, and any disputes will be resolved with the Executive Committee of the CWPAB and the Canal Winchester School Board.
- I understand that Marching Band season is a demanding time for the students and directors. I agree to volunteer my time where/when ever needed to ensure a safe, productive, and outstanding experience for all marching band students.
- I understand, the CWPAB is a Parent Booster Organization separate from Canal Winchester Schools and submits all financial data to a fee-for-service CPA firm to retain accountability at all times.
- I understand, all Marching Band fees are separate from Canal Winchester Schools Pay-to-Play Fees.
